It was brought up that the planning for Harlow View will be re-applied for as soon as the election is over. This has come from a source within Keyland. We have applied for this area to be included in the CAV but it was not agreed as it is operational land. This begs the question that if they are classing it as operational then how can they build on it. We have written to the CE of Kelda to get them to re-think the planning. DF – whilst petitioning for housing down Cold Bath Road it was noted that Harlow Hill is the first bit of green land you come to after Cold Bath Road. We should have more to do with them.

RL – was asked if we are talking to FoVG regarding the balsam in the VG. JB answered that their priority has been the planting & tending to VG rather than balsam. Most balsam is in the area that comes under the PCG anyway.

It was asked who owns the strip between Linden Homes & the Pinewoods – that belongs to Yorkshire Water.

PI – what can be done about the amount of grey squirrels in the woods as they damage the trees & the bird boxes. We do not plan to do anything about them.
